The six applicants were: Jenny Canning, Graham Clark, Stephen Golden, Jaqueline McCully, Jerry Murphy and Pat Toft. After these presentations the Council closed the meeting to the press and public to allow the Council to discuss the candidates.

### 151/17 APPOINTMENT OF ORDINARY VACANCIES - to co-opt by vote four Parish Councillors for Flamborough following verbal presentations from all candidates

The Council re-opened the meeting to the press and public and voted for the four candidates they wished to co-opt onto the Council. On the first vote the results were: Jenny Canning 6 votes, Graham Clark 3 votes, Stephen Golden 3 votes, Jaqueline McCully 7 votes, Jerry Murphy 3 votes and Pat Toft 5 votes. Thus Jenny Canning, Jaqueline McCully and Pat Toft all had a majority of votes. The Council voted a second time on the remaining three candidates and the votes were Graham Clark 1 vote, Stephen Golden 1 vote and Jerry Murphy 5 votes.
