## 145/14 Public Participation Session (15 minutes):

## Resident of Allison Lane

Referred to December 2014 minutes which noted that the Council had approved preliminary
plans for development of the Waud Bros site on the basis that this would benefit the village.
Expressed concern that locating a retail business here would increase traffic using Allison Lane
and also the issue of asbestos in the current building. It was explained that the general
consensus of approval related to the redevelopment of the site based on the preliminary plans
only and that no formal planning application has yet been submitted for approval.

Litter

• Following concerns raised at February 2015 meeting, a resident mentioned that the village particularly around Dog & Duck Square had been cleaned by a team from ERYC. Clerk responded with details of ERYC cleaning schedule and equipment as previously requested – see Clerk's report for full details.

#### 147/14 To receive the Clerk's Report and Action Log:

**Tour de Yorkshire** – Clerk to attend a briefing by Yorkshire Forward on 26<sup>th</sup> February 2015 regarding stage 1 of the race. Report to follow.

**Elections 2015** – nomination packs are now available from the Clerk. The nomination period runs from the publication of the Notice of Election, which will be 30 March 2015 to the close of nominations at 4.00pm on Thursday 9 April. Nomination forms must be delivered by hand to County Hall in Beverley. **Street Cleaning** – ERYC responded to the concerns raised on behalf of the residents from February 2015 meeting. The village is mechanically swept every six weeks and litter bins are emptied every day. The next gully sweep was scheduled for 27 February preceeded by a letter drop on 26 February for residents on High Street, Post Office Street, Dog & Duck Square, Tower Street and Chapel Street to support this. The village is scheduled for a walk round with the village task force representative in August of this year.

The Clerk met with Nigel Rogers from ERYC Street Cleansing team on 27 February to discuss various issues whilst he was overseeing a thorough clean of the village streets, particularly around Dog & Duck Square, which included mechanical gutter sweeping with additional areas being swept by hand, as well as the gully cleaner being in operation. The gully sweeper operates on a six week rota around the East Riding. It was noted that although residents had been notified of the gutter cleaning, there were still a noticeable amount of cars parked which hindered the process. The Village Task Force operates from approximately March to September on a three week rota.

Following a report from a resident of a large amount of litter at North Landing, the Clerk and Mr Rogers visited the site and observed that the ERYC wheelie bin was full and that a significant amount of rubbish surrounded it. This was organized to be removed that day, however it was also noted that the bin had been used to dump building rubble (plasterboard, bricks) which made the bin extremely difficult to move in order to be emptied.

**Metal Detecting** – Following reports of metal detecting activity taking place on Tower Fields, this was referred to English Heritage as the site is a Scheduled Ancient Monument which prohibits any such activities. EH have responded to say that anyone observing further metal detecting on the site should report this to the police and quote log number 353 02/03/15. The owners of the site have also been contacted to remind them of their responsibilities.

**Cycle Stands** – cycle stands to be installed at Danes Dyke and South Landing by ERYC. Installation due to be completed by the end of March, with nearby residents notified of installation date by ERYC.

**Toilet Cleaning** – Geoff Liddan on annual leave from 09/02/15 – 16/02/15, Lisa Bell-Latz covered.

**Clerk's hours** – 64 hours worked in February, no hours in lieu. Clerk will be on leave from 16/03/15 – 20/03/15, 8 hours annual leave remaining to be carried over to 2015/16 entitlement.

## **Councillor Grainger**

- Noted that a light is missing near the war memorial Councillor Villani stated that he had already reported this and it had been made safe

## **Councillor Smales**

- Raised the poor state of the road at the lighthouse. Councillor Matthews informed the council that this had been identified and a submission to the capital programme of works for renewal of the road surface had been made.
- Continued problem with dog fouling.
- Requested a representative from the Council to lay the wreath at the Carol Sandra memorial in May. Councillor Emmerson to undertake. Flags will be left with Councillor Crossland during Councillor Smales absence.
