 Flamborough Head Maritime Forum – Councillor Matthews has confirmed that the Forum is no longer in existence. Heather Davison – ERYC Flamborough Project Officer noted that "... the Maritime Forum has been inactive for quite some time - the most recent meeting minutes I have access to are from early 2012. Since then, the Management Scheme (who used to facilitate the Forum) has responded to reductions in funding and officer capacity by focusing efforts on the legal obligations of conserving and managing the European Marine Site. We try and have a presence at local events where we can and we regularly work with user groups to discuss specific issues, however we no longer hold a general meeting for the wider community to attend.Nevertheless, I'dbe happy for the Parish Council, or individuals, to contact me directly if there is anything about theEuropeanMarineSitethattheywouldliketodiscuss."

- North Wolds Lions Donation The Clerk received a confirmation phone call from Keith Harris that our request for £200 for a memorial bench to Mary Sunley has been approved and to go ahead with purchase. A cheque will be issued for the amount after 14 June 2016 when the treasurer is back from holiday.
- Citizen Link Councillor Grainger reported an incident on 25 May when ERYC replaced the padlock on the door following an attempt to gain access to the building. The Clerk spoke to Glen Rawding (ERYC Assistant Principal Engineer) who had been tasked to decommission the kiosk across the East Riding and was not informed that the parish council had taken on the lease for Flamborough. As a result he gained access to read the electric meter and replaced the broken padlock. As a result of this conversation, he has undertaken to try and obtain a replacement door free of charge, with a working locking mechanism from one of the kiosks that will be decommissioned. The Clerk has submitted a request in writing to this effect.
- Street Lighting A further complaint was received from the resident of the adjacent property to
 object to light filtering into her house and anticipated problems caused by dogs fouling near the
 lamppost and they requested a meeting to discuss these objections. The Clerk invited her to the
 June meeting but this offer was declined and she is now making reference to legal advice. The Clerk
 has referred the matter to ERNLLCA for advice.
- **Pre-School Fence** Fence has now been erected. Pre-School have asked for clarification on where responsibility for the grass cutting of the fenced area lies. This has not been specified in the licence as this dealt with the fence specification only.
- Village Planters A complaint has been raised by Sharon Treadwell over the flower planter boxes and troughs around the village are looking uncared for and neglected. Mrs Treadwell has offered her assistance to look after the plants once they have been reinstated. Councillor Morton has spoken to Mrs Treadwell to discuss further.
- Toilets Annual NICEIC Certificate this has been received. The installation is deemed to be in a
 satisfactory condition and suitable for its intended usage with no items adversely affecting electrical
 safety.
- Clerk's hours 64 hours worked in May.
