Minutes of the Meeting of Flamborough Parish Council held at the W.I. Hall, The Green on Monday, 3rd January, 2000.

Present: Cllr. Mrs. M. Sexton (Chairman), Cllrs. R. Allerston (Vice Chairman), Cllrs. N. Hall, Mrs. L. Gibbon, Mrs. M.P. Major, R. Griffin, J. Crossland, Mrs. M.A. Newlove, Mrs. M. Stafford, D. Whelpton & G. Scrowston.

Cllr. G. Scrowston requested an item to be Minuted as follows:

Madam Chairman, Before this meeting commences can I please have it minuted that this meeting is not a properly convened meeting in accordance with Standing Order No. 2. I am concerned at the disregard of Standing Orders. I cannot condone this and must register a protest as if not this could happen again."

The Chairman pointed out that Standing Order 2b applied. This had been a matter of discussion at the end of the previous meeting but not included on the Minutes as it was not an item on the Agenda. Cllrs. G. Scrowston, N. Hall, J. Crossland and Mrs. M.A. Newlove left the meeting in protest. The Chairman asked the remaining Councillors if they wished the meeting to be postponed but they expressed the wish to carry on with the business in hand.

2. Apologies for absence were received from Cllrs. C.R. Harrap, J. Wilkinson and E. Dunn.
3. Questions by Electors - None.
4. Minutes of the Meeting held on the 6th December were proposed to be accepted by Cllr. R.A. Allerston, seconded by Cllr. R. Griffin. All in favour.

5. MATTERS ARISING.

8. MILLENNIUM PLANS. It was reported the Planning Approval had been received but work had not been completed.

14) ALLOTMENTS. The Chairman reported that the Pig Netting had been obtained and this would be completed when weather improved.

7). POLICING OF FLAMBOROUGH. It was reported that Flamborough had been included in the new Community System and was in Area 4 with 2 Sgt. and 4 Constables. The Number to ring for a non-emergency incident is 402726. The number is a Voice-Mail System and each message would be passed on to the Team Sgt. in Area 4. People should still ring 999 in an emergency.

12. REPORTS FROM NOMINEES/MEMBERS WITH PARTICULAR INTEREST.

Cllr. Mrs. M. Stafford reported on the Village Hall Meeting held on the 13th December as follows: Final arrangements were made for the Village Hall Bingo.

Miss Mummary has been appointed to take over the Caretakers job from 1st January.

The Grant from FAST for a further 10 tables has not been applied for as a previous application for the same items had already been granted. Mrs. Whelpton was informed that a further application would not be approved in this present budget.

A discussion followed regarding the modernising of the toilet facilities with accommodation for disabled people. A Committee Member asked if it would be possible to have separate doors for men and women. It was agreed to ask for an overview/plan and estimates from West & Heatons, Graham Gratrix and Wauds. Grants are available.

An appeal for a Piano - the present one has had its day. It was decided to see if there was any response from the report in the Free Press. If not, then an appeal on the local radio.

Senior Youth Club There have been no problems but the situation is still being reviewed every 6 weeks. Limiting the age seems to have helped considerably with the vandalism problem.

New stays had to be fitted to one of the windows damaged by a Youth in the Village. PC Noble was involved. It was agreed to send a copy of the invoice (estimated at about £50) to the Youths Parents.

Members of the Bowling Club have complained about a draughty window. It was also mentioned that the lock on the front door was suspect. Both of these faults to be looked into and reported to EYG.

The state of the floor, which is very uneven, was mentioned but was deferred for now.

The Treasurer Mr. Turton gave his report on the finances.

Cllr. R. Griffin gave his report on the Conservation Committee Meeting stating that the Crofts Farm 2 Bedroomed Cottages were approved subject to the front of the dwellings being Chalk and the Chimneys to be on the Ridge.

13. QUESTIONS.

It was reported by Cllr. Mrs. Stafford that the seat on the Green near the W.I. Hall had not yet been fixed. The employment of a Handyman was discussed. The question of Insurance arose and it was thought that as he would be employed by the Parish Council, the Councils Employers Liability should suffice. The Clerk was to enquire from the Insurance Company.

Cllr. Mrs. Gibbon reported the Shrubs had still not been dealt with on Constable Road. The Clerk was asked to ring Mr. Fisher once again.

It was reported that the trees were overgrowing and covering the Street Lamp on Lighthouse Road outside Manor House. It was also reported that the light on Woodcock Road was on day & night.

The date of the next Meeting was fixed for Monday, 7th February at 7.30 p.m. There being no further business the Chairman closed the meeting at 9.15 p.m.

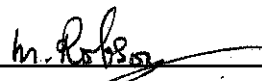

8. PLANNING APPLICATIONS.

Cllr. Mrs. M. Newlove declared an interest.
Mr. E.J. Hall, 17 Acorn Close, Bridlington. Conservation Area Consent for the demolition of Coal Loading sheds at Coal Yard, Greenside, Flamborough. No objections.

Mr. E.J. Hall, 17 Acorn Close, Bridlington. Erection of 2 Starter Homes and provision of parking/amenity space. No objections.

An appeal had been made to the Secretary of State by Mr. S. Wolski, Avanti, South Sea Road. The Council had made no objections but wished screening to be carried out.

9. PLANNING DECISIONS.

Thornwick & Seafarm Holiday Centre. Orange PCS Ltd. Planning not required.

Mr. & Mrs. Buckley, Flaneburg Hotel, North Marine Road. Erection of Conservatory. Approved.

Flamborough Holidays Ltd. Caravel Restaurant, North Landing. Change of use of part of shop to form extension to existing snack bar. Approved.

9a. HIGHWAYS & STREET LIGHTING.

Cllr. Hall wished to draw Councils attention to the need of the Street Light on Victoria Terrace. Also the light near the Green, South Sea Road needed re-erecting as soon as possible.

Cllr. Hall reported on the state of the roads on Bempton Lane and Lighthouse Road. Grass Verges required edging and the roadside gullies and grips needed cleaning out generally. The Clerk was to report to Highways.

10. CHAIRMANS REPORT.

Since the last meeting I have attended a number of meetings which I felt were of interest to the Parish Council.

January 19th. Flamborough Environmental Action Group. Also attending were Cllrs. Mrs. Stafford and Mr. Crossland.

The aims of the group are very commendable. A number of projects were discussed - the fence round the play area caused me some concern as funding had been available but without any consultation with the Parish Council. Another was a composting scheme, one member suggested could be sited on the Allotments - I did say this would be a matter for the Parish Council to discuss and decide.

January 29th. I attended a meeting of the Residents of North Landing (but only as an observer) due to the change of Landowners, the Leaseholders seem to be having problems.

January 30th. Cllr. Mrs. Stafford, Cllr. Allerston and myself attended a meeting in the W.I. Hall to see a demonstration of a Defibulator which is used as first line treatment in cases of heart attacks. 21 Villages signed to take part in a Training Course - it is hoped that this will be a success.

A general discussion ensued about a Defibulator.

13. STREET LIGHTING. J. CROSSLAND AS CONTRACTOR.

Mr. Crossland reported on his problems he had by being given a Contract for only 1 year. He explained that to keep prices down he obtained the Lamps and Columns in bulk.

The Chairman raised the matter of the requirement of a G.39 Certificate. At the District Auditors advice the Clerk had contacted Mr. Steve Devlin of Yorkshire Electricity who had explained the requirement and sent a copy of the Code of Practice. Mr. Crossland said he had received the necessary Forms which had to be signed by the Clerk on behalf of the Council. At the time the soonest date Mr. Crossland could take a Course was the 1st April.

The Chairman stated she wished a Resolution that Mr. Crossland should not touch the Parish Council Lighting until he had a G.39 Certificate. Moved by Cllr. Hall, seconded by Cllr. Griffin.

The Specification for the new Contract was discussed, there were discrepancies in the Street Lamp numbers. The District Auditor had advised: 1. Lamp numbers be corrected.

2. Legal advice be taken on the contract.

It was agreed a meeting should take place between the Council Representatives and E.R.Y.C. Lighting Officers and report back to the next Meeting.

A letter from E.R.Y.C. Lighting Officer was read out to Mr. Crossland expressing his concern on certain aspects on the maintenance of street lighting.

14. QUESTIONS.

Cllr. Crossland reported a letter he had received from the Chairman stating that she had received a Telephone call from the Health & Safety Department regarding him using the Digger/Bucket. Mr. Crossland reported when he used it to take down the Xmas Lights he was working for himself and not the Parish Council and if he had used the Hydraulic Tower he would have blocked the road.

The letter received from Lancasters Solicitors was read by the Clerk and it was resolved a copy should be sent to each Cllr. for them to make comments back to her.

15. DATE OF NEXT MEETING. This was fixed for Monday, 6th March at 7.30 p.m.

The Chairman closed the meeting at 10 p.m.

Minutes of the Meeting of Flamborough Parish Council held at the W.I. Hall, The Green on Monday, 6th March, 2000.

Present: Cllr. Mrs. M. Sexton (Chairman) Cllr. R. Allerston (Vice-Chairman) Cllrs. N. Hall, J. Crossland, Mrs. M.A. Newlove, Mrs. M. Stafford, G. Scrowston, R.W. Emmerson, R. Griffin, E. Dunn and Cllr. J. Wilkinson in attendance.

1. The Declaration of Interest was read by the Clerk.
2. Apologies for absence were received from Cllrs. D. Whelpton, Mrs. M. Major, Mrs. L. Gibbon and C.R. Harrap.
3. Questions by Electors - None.
4. Minutes of the Meeting held on the 7th February were proposed to be accepted by Cllr. R. Allerston, seconded by Cllr. Mrs. M. Stafford. All in favour.

5. MATTERS ARISING.

8. Millennium Plans. The Flagpole had been completed but the Flag had not yet been purchased. The Chairman raised the subject of the photograph in the Bridlington Free Press and showed concern that the Parish Council had been unaware of the publicity and thought Cllr. R.W. Emmerson should have been included. Following a difference of opinion with Cllr. Crossland Cllr. Dunn left the meeting.

The Clerk confirmed that the £1000 Grant from Leader II had been applied for.

WEST STREET. A number of telephone calls had been made about the flooding and blocked drains. The Clerk reported she had seen the Automatic Cleaner in the Parish again but the cleaning out of gullies was awaited.

CROFTS HILL - TRAFFIC CALMING. A reply had been received from Mr. Colin Stephenson stating that investigations and consultation with the Police were complete and finds this Route falls into a low category rating for providing physical traffic calming measures. The only measure that can be offered is to introduce a 40 p.m.h. speed limit leading into the existing 0 m.p.h. speed limit. Cllr. Hall proposed this should be accepted. All in favour.

OVERGROWN TREES LIGHTHOUSE ROAD. This had now been carried out.

POLICE LIAISON COMMITTEE. It was reported a meeting was to be held at the Town Hall, Bridlington on Wednesday, 8th March and would be attended by Cllr. Mrs. M. Sexton and the Clerk.

DEFIBULATOR. A successful meeting had been held with a number of Parishioners showing a great deal of interest. The Chairman explained to Council how the machine would be manned.

6. CORRESPONDENCE.

A letter had been received from John Townend F.C.A. M.P. enclosing a press cutting from the Sunday Express outlining the threat to the future of Parish Councils by the Labour Government who are looking to abolish Parish Councils and investigating "Neighbourhood Forums" which are meetings where residents can attend to talk about local issues and make comments about Council Services. This would end representative democracy and the majority of local residents who could not attend would lose their democratic voice. The Council resolved unanimously that we should write to the House of Commons giving our full

support on how Parish Councils can be protected and improved.

A letter had been received regarding the Environment Protection Act 1990 asking if Council knew of any land within the Parish which may be contaminated. Following discussion it was noted that there used to be an official 'Tip' at the Brickyard, Flamborough Road.

A letter had been received from Humber and Wolds Rural Community Council regarding the Impact of Post Office Closures caused by the change in method of Benefit payments. Council feel strongly in favour of keeping our Post Office which is the 'Lifeblood' of the Parish. The Clerk was asked to reply accordingly.

A letter had been received from Flamborough Sword Dancers with a request for a Donation towards their Trip to Belgium. The April Meeting would be too late for their sponsorship. It was proposed by Cllr. R. Allerston and seconded by Cllr. R. Griffin that £100 be donated. All in favour.

7. ACCOUNTS. (Cllr. Crossland declared an interest)

The Payments due for 6th March were discussed. The Chairman queried the completion of work by Mr. Crossland. The replacing of concrete light columns were now complete but the concrete base of the seat near the W.I. Hall still required attention. It was resolved to hold back that Invoice in the sum of £73.43. until the work was complete.

Cllr. Hall expressed his concern at the cost of the telephone calls made by the Chairman who said he could view the Account if he so wished. Cllr. Mrs. Newlove declared she did not agree the telephone account be paid. In reply to Cllr. Halls comments the Chairman made a statement. Cllr. Griffin requested that Statement be put on File.

It was resolved all accounts be paid with the exception of J. Crosslands Seat Invoice.

8. PLANNING APPLICATIONS.

Flamborough Victoria Club & Institute. Construction of an external fire escape to rear of property. No observations.

Vodafone Limited. Erection of a mobile telephone base station at The Grange, Bempton Lane. No observations.

9. PLANNING DECISIONS.

Mr. S.R. Harrison, Mechelin, North Marine Road, Flamborough. Erection of greenhouse/sun room and alteration to roof of existing premise. Approved.

10. MOLES - CROFTS HILL. This problem was discussed at great length but no action was taken.

11. STREET LIGHT VICTORIA TERRACE. (Cllr. Crossland declared an interest)

Cllr. Hall had raised this matter as there was a need for the replacement light. Cllr. Crossland was asked to look at the best place to fit this installation which would cost £340. It was proposed by Cllr. R. Allerston and seconded by Cllr. N. Hall that this work be carried out as soon as possible. Council agreed with the abstention of Cllr. Griffin.

11a. HANDYMAN. This was discussed and it was reported that the person in question was Insured himself and would be contracted to work as a when required. The Clerk was asked to establish the hourly rate.

12. CHAIRMAN'S REPORT. As attached.

13. CLERKS REPORT. - None.

14. REPORTS FROM NOMINEES/MEMBERS WITH PARTICULAR INTEREST.

Cllr. Mrs. M. Stafford gave a report on behalf of the Village Hall as attached.

15. STREET LIGHTING. It was reported a meeting had taken place with Mr. G. Woodhall of E.R.Y.C. and Cllrs. M. Sexton, J. Crossland, R. Griffin, & R.A. Allerston and Mr. R. Sunley a former Councillor to discuss the ownership of certain street lights in the Parish which were under question. A letter of confirmation of ownership was still awaited from Mr. Woodhall.

It was also reported that a copy of the G.39 Certificate from Yorkshire Electricity had been received from Mr. J. Crossland.

16. QUESTIONS.

Cllr. Scrowston brought to Councils attention the number of times Car Boot Sales can be held in a Parish, this being 14 times a year. He pointed out that last year it was held 18 times.

The rubbish on the allotments was discussed and the Clerk was asked to place this on the next Agenda.

The Chairman said how nice North Marine Road looked following the planting of shrubs carried out by Flamborough Heritage and requested that a letter of thanks be forwarded to them.

17. DATE OF NEXT MEETING.

This meeting being the Electors meeting was fixed for Monday, 3rd April at 7 p.m.

The Chairman closed the Meeting at 10 p.m.

CHAIRMAN'S REPORT 6th MARCH 2000.

The main concern since the last meeting is the increase in the Community Charge by E.R.Y. Council and the effect it is going to have on Flamboroughs large population of retired people who already have to cope with increases in the cost of living such as petrol, car tax and insurances. It does appear that Pensioners are being punished for being thrifty during their working lives.

Community Charges are becoming a highly political subject, when the Government of the day keeps broadcasting the increases in its funding towards some of the major local services such as Education, Health and Social Services.

Cllr. Ian Male is quoted "that the majority of the money is going to education" and blaming cuts in education during the first two years of the present Council, yet David Blunkett M.P. keeps saying more and more money has been put into Education since 1997.

This political 'knockabout' does nothing to ease the burden on Pensioners facing these increases.

I would like to propose a letter be sent to the Chief Executive of E.R.Y. Council from this Parish Council setting out our concern for these year on year increases in the Community Charge and its effect on a most vulnerable section of Flamboroughs community, many of whom have to live on fixed incomes, a 73p rise in pensions is no consolation.

The Parish Council has always prided itself in bearing in mind the number of retired people living in the village, it can take satisfaction in the way it considers the precept and the effect it has on the village population. For the last two years the Parish Council has held back any increase in its precept - the result no increase at all.

VILLAGE HALL REPORT.

Approximately £246 was raised at the Christmas Bingo.

A piano has been donated by a Villager and the old one was kindly removed free of charge. A piano tuner is booked to come Friday the 10th February (All we need now is someone to play it).

The cost of repairing the window which was damaged by a Youth was £47. It was agreed to send the Invoice along with a covering letter to the Youth's parents. Concern was expressed with regard to a Youth (who is a Club Member) and his Mate (who is not), both have been hanging about outside. The Police have been informed but up to present nothing has been done.

Two prospective bookings - A Millennium Party for the over 70's and St. Catherines Hospice. Both these organisations have asked if it would be possible to use the Hall "free of charge". Members felt this would be setting a precedent and agreed to charge the normal price but to make a donation to each.

A Bill for £329 for Servicing the Boiler had been received. The Committee felt this amount to be excessive and agreed to make further enquiries into other firms and quotes. The Chairman said he had asked Mr. Whelpton to have a look at the disabled toilet proposals. The existing toilets were considered unsuitable to include a disabled toilet. Mr. Whelpton kindly drew up a Plan to include the new toilet on the right hand side of the entrance. Two quotes had been received. One for £4,238.32 plus VAT and the other for £3,952.70 (inc. VAT) After consideration all Members were in favour of accepting the Plan and the lower quote for the job was accepted. A 60% Grant is to be applied for.

A Member expressed concern that nothing was being done to update the existing toilets. The Chairman said this would get done in time.

The Chairman closed the Meeting at 9.25 p.m.

Questions by Electors.

Gordon Charlesworth spoke first. I haven't seen any Petition and not signed anything but I must support the team and the local Contractor. Could you tell me, has Mr. Crossland been doing this work for over 10 years, 13.5 years or 25 years? - Reply 13.5 years. How many of those years was a G.39 required? Reply 10 years. How many times has his work been criticised in writing? Chairmans reply. We have got on File since last January correspondence from various Departments and one is the Chief Lighting Engineer in Beverley drawing the Councils attention to some of the shortcuts and these were drawn to the Contractors attention. Mr. Charlesworth. I still disagree with paying another Contractor £475 in excess of the Local Contractor. I am all for keeping money within the Parish.

D. Harvey. I am a local of Flamborough for 60 years, served on the Parish Council for 10 years. Why were the E.R.Y.C. taking photo's of lighting at the Lighthouse? As I understand, it is still under Mr. Crosslands contract. Also, could the Parish Council contact Mr. Seymour to ask him the name of the person who first got in touch with him about the hedge at the Allotments as it has cost the Council a lot of money?
The Chairman said she was sorry she did not know who was taking photographs and they hadn't been given authority by the Council.

D. Turton, Tower Street. Just a comment about certain lights in Bridlington which was out for over a week, perhaps just waiting for the correct forms to be filled in. Are we going to have lighting as good as the Railway System?

Geoff Jackson, Stylefield Road. Just one small problem. Mr. Crossland should have had a Certificate 10 years ago, had the Council slipped up by not asking for that Certificate all that time? Reply by the Chairman. The fault of that I would say was the former Clerk and the former Chairman. There was nothing on File when our Clerk took over, there was no dated contract and no G.39 and there was no record of numbers and this is why we are trying to put things right.

Robert Emmerson. If Mr. Crossland has been doing this work for 13.5 years how many times has the Contract been renewed. Chairmans reply. There has been no contract. The Council wanted to know why. The previous Clerk had been in touch with Mr. Crossland and we have a letter on File where the previous Clerk is saying to Mr. Crossland, as you haven't got a contract we are going to put one together and it was brought to the Parish Council meeting of that time and that is how we got a contract together.

Arguments went on which was not understood on tape.

David ? Southsea Road. I understand that with the Contract being taken away from Mr. Crossland there will be no Xmas Tree or Lights. Now, who is providing the Xmas Tree - Reply by Chairman, We will. It will be put to the Parish Council later.

G. Charlesworth. According to the Minutes you said the contract had been fully discussed at the last meeting. Chairmans reply. No I didn't. Is said Members dissatisfaction over a period of time on the working practices of the Contractor and I read out points 1 to 5. The Clerk stated she read out to Contract at the meeting but it was not discussed by you.

The Chairman was asked, if a Street Light and concrete standard was knocked over would the E.R.Y.C. be prepared to come out within 10 minutes, make it safe and remove it. Would they do that and if not, who is going to do it? Another thing, if you take this contract from Mr. Crossland can you think of all the free work that Cllr. Crossland puts into this village? I can start with Swings, the Pump at the bottom of Crofts Hill, the War Memorial, Bus Shelter. A lot of the new Councillors don't know how much has gone into this village by Members of the Parish Council.

The Chairman said it would be most unfair if you expect Councillors to sit here and judge contracts having to bare that sort of thing in mind.

Robin Sunley. He stated that the Street Lighting was purchased over 30 years ago. With regard to the G.39 he had known nothing about that, neither had Mr. Crossland. The Borough Council may have known and the County Council but the Parish Council did not. Mr. Crossland, at his own expense obtained his City & Guilds. He now has that and the G.39 is irrelevant because that is for a new Contract and for a new contract he now has the G.39. Regarding the removal and replacement of Columns without authority, if you engage a Contractor and place upon that Contractor responsibility not only under the Electricity at Work Act 1988 but the Health & Safety Act of 1974 and that Contractor must make something safe that he finds unsafe now you can if you wish have a fault. Knock it down and create another hazard. That cannot be criticism of the Contractor, in fact he has taken it upon himself that responsibility that he is to have because of the contract. You say there was a failure in saying what Columns and Number of lights. Surely the person producing the Contract should say "I want X number of lights maintaining". If they don't then they haven't the knowledge and I know for a fact that not only did you not have the knowledge but the Council do not have the knowledge of what they own or maintain and for the benefit of the people that don't know, we have already paid twice for some of these Street Lights because you didn't know.

The Chairman replied that was why we had to put things right because it was getting out of hand.

Mr. Crossland asked if he could speak. I didn't know anything about the G.39 until it was put to me just over a year ago. When I made enquiries I was told this was a qualification which by the way is a one day Course. When I was made aware of it I got in touch with Y/E. It took me a week to find anyone at Y/E who knew about it. When I did I managed to get on the Course within a fortnight with some other people and we got it done. Also I gave the Certificate to the Clerk to get the Councils Authority which no one knew about. Replacement of Columns with authority to do it. There has been a Rolling Programme since before you ever came here Madam Chairman.

Faulty Columns. We were made aware of these by a firm called Stanton who made them 12.5 years ago a copy of a letter which you have got which I received at the time. Just after I started to do it we got a call to say that these were beginning to fail. There has been a Rolling Programme. We had 75, 51 have now been replaced by myself, the 24 remaining have been reported to you and to the Clerk on numerous occasions as being dangerous.

An argument was apparent between the Chairman & Mr. Crossland about one Lamp reported to the Clerk which the Chairman said was alright.

The Opening of the Highway we have gone on about on numerous occasions. We have done exactly what we were told on this. Any new Columns we find out now has got to go through the Authority. They didn't always do this. When I first took over they didn't have to but there has been a change of Authority. When it was H.C.C. it didn't matter. Flamborough Parish Council is the Street Lighting Authority not like some other Parishes. I don't know what else I can say, we have done everything that is possible and I'm afraid it is just a vindictive thing. Another thing I think the Members of the public should know. When we were taking down the Decorative Lighting last year somebody reported us to the Health & Safety Executive because we were using George Thompsons Forklift with the bucket so as not to block the road off with our Lift. When I made enquiries it was Cllr. Allerston that rang the Health & Safety man Mr. Hartley on the instruction of the Chairman who had reported to him to ring the Health & Safety to tell him we were using a dangerous tractor. Cllr. Allerston said it was a Resident and as a Councillor he was doing his job.

Members of the public asked if the Clerk would bring it to the attention of the District Auditor. The Clerk reported she was already in touch with the District Auditor.

The Chairman said she knew we wouldn't satisfy what they wanted. Our job is, as I said at the beginning, to work on in the best interest of the village. The Council cannot condone short-cuts and breaches of regulations. It is not the Contractor that takes the backlash, it is the Council themselves.
