- 1. **APOLOGIES FOR ABSENCE** Apologies for absence had been received from Councillors Mrs L. Bennett and R. Emmerson .
- 2. **DECLARATION OF INTEREST** The clerk read a statement regarding Declarations of Interest. Any declarations of interest, which may have been made by Councillors, are recorded after the appropriate minute.
- 3. MINUTES OF THE MEETING HELD ON 3<sup>rd</sup> DECEMBER 2001— Councillor N. Hall was not present having sent his apologies, the Minutes were otherwise AGREED— That the minutes of the Parish Council Meeting held on 3<sup>rd</sup> December 2001 be received and signed as a true and correct record.
- 4. MATTERS ARISING FROM THE MEETING HELD ON 3<sup>rd</sup> DECEMBER 2001.
  - (a) Trees on the Village Green The meeting with tree officer to be held on 12<sup>th</sup> December 2001 was cancelled and will be re-scheduled.
  - (b) Vandalism Cllr Pearson commented that vandalism is still a problem with several residents frightened by the disruption caused by these young people, nothing has yet been done although he agreed the Police are very busy.

    PC Cross in attendance at the meeting advised that no damage has been reported in the past month. which may be due to a larger police presence during different hours of each day. A Letter has been sent to sixteen parents as a result of operation 'Fairway'. He emphasised the need for anyone witnessing any crime to use the 999 procedure however there will be a police office in the village from 1st February for a six month trial period.
  - (c) Abandoned Vehicles Cllr Harrap reported that ERYC have produced a scheme to ensure vehicles are removed within 24 hours following statutory waiting period.
  - (d) Public Conveniences The Chairman reported there has been no response from the ERYC even though this is a matter of some urgency.
  - (e) Christmas Tree Lighting Thanks were expressed on behalf of the village for the work by Cllr Crossland and family, Cllr Couzens and family and Cllr D Harvey.
  - (f) The Carol Service was a great success and thanks to everyone who helped in any way. The Council hope that this will become an Annual event.
- 5. **QUESTIONS BY ELECTORS** In response to an enquiry about the Heritage Centre at South Landing, Councillor Hall advised that interest has been shown by several parties.

The meeting was held in the W.I. Hall, The Village Green, Flamborough.

- 1 **APOLOGIES FOR ABSENCE** Apologies for absence had been received from Councillor R. Emmerson and Ward Councillor R. Harrap.
- 2 **DECLARATION OF INTEREST** The clerk read a statement regarding Declarations of Interest. Any declarations of interest, which may have been made by Councillors, are recorded after the appropriate minute.
- MINUTES OF THE MEETING HELD ON 7<sup>th</sup> JANUARY 2002 it was AGREED that the minutes of the Parish Council Meeting held on the 7<sup>th</sup> January 2002 be received and signed as a true and correct record, with an Amendment to Minute 14 as per Standing 0rders 34a that the decision made on Lighthouse Bus Shelter be discussed again as further correspondence had been received from Mr J Warcup.
- 4 MATTERS ARISING FROM THE MEETING HELD ON 7<sup>th</sup> JANUARY 2002.
  - 4(d) Public Conveniences: The draft contract has been prepared for approval but the Land Registry Title Plan confirming permanent access is required before any further action can be taken. Access has been obtained for the draft drawings which will then be submitted to an extra-ordinary council meeting to avoid undue delay.
  - 9(a) Gas Light: Cllr Crossland is awaiting information from the manufacturer.

Ditch: Cllr Hall advised that the school have requested ERYC to clean the Ditch.

- 11 Citizen Link: Building sited outside the Library. Completion March 2002.
- 14 Bus Shelters:

North Landing: Plans have been submitted to ERYC.

Lighthouse: A letter together with photographs of the shelter have been received from Mr Warcup requesting that the Council reconsider their decision not to demolish the shelter. The Council were advised that East Yorkshire Motor Services have no immediate intention to operate a service on this route, the school bus now only travels to the Lighthouse. Cllrs. D. Harvey and Bennett confirmed the children do not use the shelter. Mr R. Waines of Head Farm had reported that the shelter and the immediate area has been rat infested.

Each Councillor was asked for their opinion by the Chairman.

Several recommendations were considered including re-siting, repairing and the removal of the shelter. If the shelter was to be demolished the amount saved against any repair could be used for a new shelter should a bus service be re-established.

Cllr Scrowston proposed an amendment to minute 14, seconded by Cllr Bennett that the shelter be demolished.

The amendment was passed by 8 votes to 4.

Cllr Hall advised that a Grant could be sought for any future replacement.

### 5 OUESTION FROM ELECTORS

Mr Murdoch enquired as to when and where the proposed Police Office would be open and situated. This will be at the old Bank in Post Office Street and will open once the Police Authority Authorisation has been received.

A Police sign will also be erected.

Mr P. Traves wished to express his objection to the demolition of the bus shelter.

#### 6 OUESTIONS BY MEMBERS

- (1) Cllr Hall submitted a copy letter received from the North Marine Road residents requesting ERYC consider parking bays or residents permits. PC Cross commented that parking on grass verges is an offence.
- (2) Cllr Gilson reported that Donkey Lane now has a 'No Entry' sign at one end and a shut gate at the other restricting vehicle access. The Clerk asked to obtain Right of Way details from County Hall.

#### 7 NEW COMMITTEES

Allotments: Cllr Couzens has been advised that Mr Woodcock is no longer available to cut the hedge. The Council agreed that Mr P. Crossland may take over this work.

War Memorial: Cllr Scrowston stated that all documents have been sent to The Royal Commission for Historical Monuments in England for registration.

Sports Club Trust: Cllr D. Harvey reported he had attended the recent meeting and large funding is required for the tennis courts and the cricket pavilion. Mr W. Traves the Secretary of the Sports Club has requested a new lease from the Parish Council for a period of 21 to 28 years to enable the Trust to apply for Lottery funding, acknowledging they will pay for their own Insurance. Cllr Crossland observed that Trustees must sign the Lease. New Trustees are being appointed by the Trust on 20<sup>th</sup> February 2002. It was agreed Cllr Scrowston check and update lease.

#### 8 PLANNING APPLICATIONS

- 1. North Star Hotel: Extension to the rear dining room, no observations. Interest declared by Cllr Traves.
- 2. Bowling Club: Store, no observations.
- 3. Red House, Lily Lane: Garage at the rear. An objection by Cllr D. Harvey, seconded by Cllr Crossland that the garage is not in the building line.

- 1 APOLOGIES FOR ABSENCE Apologies for absence had been received from Ward Councillor J. Wilkinson.
- 2 **DECLARATION OF INTEREST** The clerk read a statement regarding Declarations of Interest. Any declarations of interest, which may have been made by Councillors, are recorded after the appropriate minute.
- P.C. Cross attended the meeting advising the Council that the Police Authority have decided not to open a Police Office in Flamborough, and due to a change in shift patterns may loose Police presence in the village. He has not received any reason for this course of action. The Council expressed their shock and dismay at this decision as it is a complete reversal of police policy as indicated last year at the meeting with the local Chief Inspector.

Cllr. Hall will bring this decision to the attention of the Police Liaison Committee. The Chairman proposed an addition to the agenda under item 16a to allow further discussion. Interest declared by Cllr Crossland who left the Meeting.

- 3. MINUTES OF THE MEETING HELD ON 4<sup>th</sup> FEBRUARY 2002 Cllr Bennett present at the Meeting, Cllr G Harvey attended Sports Club Trust Meeting it was then AGREED that the minutes of the Parish Council Meeting held on the 4<sup>th</sup> February 2002 be received and signed as a true and correct record

  - 9(a) Gas Light: Cllr Crossland is awaiting information from the manufacturer.

Ditch/Footpath, Carter Lane: Cllr Hall advised this is being dealt with.

- 11 Citizen Link; Cllr D. Harvey commented upon the poor building quality. The Clerk was requested to write to Mr N. Bravey at ERYC for his comments.
- 14 Bus Shelters:

North Landing: Plans have been submitted to ERYC.

Lighthouse: Cllr. Crossland insisted that the decision made under SO 34a was incorrect. The Clerk advised Cllr. Crossland that she had obtained advice and guidance from Mr A. Barker the Local Government Development Officer who advised on this course of action. Following further discussion Cllr Pearson proposed that the amendment to the Minutes under SO 34a be accepted as correct, this was seconded by Cllr. Major, nine for and four against.

Matters arising contd.

- Onkey Lane: The Clerk had contacted the ERYC Rights of Way Department and was informed Donkey Lane is not registered as a Public Right of Way so advised to contact the Highways Department. Mr P. Cobb confirmed that Donkey Lane is an unclassified road and therefore a public highway to be maintained by the Council for vehicular and pedestrian access, there is no entitlement to erect direction signs or to bar access.
- 7 War Memorial: Cllr. Scrowston advised still ongoing.

Sports Club Trust: In respect of the application for a new lease a reply has been received from the DFES. The Education Act 1973 transferred interest to The Charity Commission. New application for renewal of lease to be issued to the Charity Commissioners.

#### 5 OUESTION FROM ELECTORS

- 1) Mrs E. Dyson: In response to the planned new housing development she asked why was the police presence being withdrawn, she agreed to have a petition in the Post Office.
- 2) Mr Murdock: What is the Council's intention regarding the loss of Police presence in the Village. Advised by the Chairman will be discussed tonight as Agenda item 16a.
- 3) Mr D Turton: Why has ERYC built a Citizen Link in the Village when it has closed Public Toilets. Informed by the Chairman that Citizen Link is funded by a Grant from the Lord Chancellor's Office and built at no cost to the Parish Council.
- 4) Nr N Emmerson: Asked why the Council had queried public access on Donkey Lane. Informed that representation had been made to the Council because of the now visible "No Entry" sign and shut gate. Mr Emmerson advised that he and Mr Stephen Emmerson held Title Deeds showing this land is theirs. Advised to contact ERYC over Land Title. Interest declared by Cllrs Emmerson and Major who left the Meeting.

The meeting was held in the W.I. Hall, The Village Green, Flamborough.

**APOLOGIES FOR ABSENCE:** Cllr C Traves

The meeting was held to decide on the refurbishment Plans for the Public toilets in Dog and Duck Square. The Councillors all agreed that set of Plans no. 2 be accepted.

Cllr Crossland advised that YWA on ERYC instructions had cut off the water supply. Cllr Crossland had contacted ERYC and told them that the water supply must be re-connected as soon as possible and at no cost to the Parish Council who are currently negotiating the purchase of the toilets.

It is now unlikely that planning permission can be obtained and refurbishment completed before the Tourist season commences as the Contract from ERYC is not ready for signature.

# It was agreed that:-

- 1. Cllr Crossland obtain a job specification from Mr C Redhead.
- 2. The Councillors inspect the toilets and decide if they can be opened for the Tourist season in their present condition.

# NOTES OF POLICE MEETING-8<sup>th</sup> APRIL 2002

The Meeting was attended by Chief Superintendent Dowse, Inspector Love and P.C. Cross who were welcomed by the Chairman Mrs M. Newlove.

Statement by the Chairman Mrs M. Newlove.

- 1. I am sure you are aware of the disappointment felt by most residents in Flamborough at the late decision by the Police Authority not to proceed with the Police Office in the village.
- 2. Whilst there is no dissatisfaction with our Community Policeman P.C. Cross and it is also acknowledged there has been an increased police presence in recent weeks, this does not resolve the basic problem within Flamborough. It is recognised this is not exclusive to Flamborough however it should be added that our population increases by up to 50% during the summer months.
- 3. Village life, particularly for the elderly and also for the business community has been deteriorating for quite some time due to the activities of these young vandals.
- 4. We are concerned about the elderly people in our village particularly those who live alone and who can be quite intimidated and frightened by this behaviour. Three youths were recently seen on a cottage roof and not for the first time, throwing mud and stones at the windows and doors and using abusive language.

Mrs Newlove hoped this provided an example of the feelings of the local residents.

Inspector Love and Chief Superintendent Dowse advised members of the public who were present of the intention of the police, adding however that they were unable to answer questions relating to specific incidents. Copies of their reports are attached, and questions were then invited.

Cllr. D. Harvey: Why was the telephone number 672222 constantly engaged? Calls were routed to a main call centre at Hessle and re-routed to Bridlington however when there is a large volume of calls these must be prioritised.

Cllr. M. Couzens: Why was the Flamborough Police House sold with the subsequent rural policing lost. This was the official decision at the time but the policy has now changed.

Cllr. J. Crossland: In declaring an interest, he i) felt there is apathy because the police cannot be contacted. ii) responding officers do not have any local knowledge. iii) The rental charge was notified in November 2001 and the premises were converted and appliances were donated by the villagers for a six month trial period.

The original decision was made without the correct police authority. Chief Supt. Dowse admitted his personal embarrassment at the decision to withdraw and accepted this was handled badly and wished to apologise.

Mr D. Turton: Commented that all villagers are paying a contribution of their Council Tax to the Police Authority and feels the Police are losing support in the village.

Mrs J. Dyson: The Post Office while experiencing problems with youngsters have not reported each incident due to the lack of response from the Police.

Mrs Dyson was encouraged to report every incident however small.

Mr A. Major: What is the period of time that must elapse before a vandalised car is removed. If the owner is not identified a 7 day removal order is applied for and it is then the responsibility of the ERYC.

Mr P. Traves: Observed that if the Police were reverting to Police Houses and rural policing the Police Office could be seen as a Police gesture towards this.

Mr Murdoch: As the fear of crime is a real problem for the elderly a Police presence is required to address this and give this section of the community a degree of confidence. In reality the residents of Flamborough have nothing to fear. Resources have to be put to real crime areas. More Police Officers have been in the village over the past three weeks.

Cllr. Hall: He was relieved to hear that there is to be an increased Police coverage and enquired how the Parish Council may be of assistance.

This can done by supporting local police teams. Pro-active rather than re-active with a dedicated team of officers for each area at core of problem solving.

Mrs P. Thornton: How do the Police intend to address the shortage of man power when there is a lack of funds.

Money is received from Central Government and has to be budgeted within the remit.

Cllr. Pearson: Although there is a weekly contribution of £2000 by the residents of Flamborough to the Police Authority there is no obvious return.

Cannot change decision on Police Office. This is a policy decision but police levels in the village can be increased at relevant periods.

Cllr Newlove: Are Special Police Constables available

Three Specials Constables in Bridlington North team and are deployed where needed.

Cllr Newlove: Still disappointed at the decision but realise it is a policy decision and presented Chief Superintendent Dowse with 380 signature petition to open Police Office.

Inspector Love: Will increase Police patrols in the village even though call levels do not support this.

Chief Superintendent Dowse concluded by apologising for not opening the Office and will attempt to introduce more regular policing.

I became the Divisional Commander for the East Riding of Yorkshire on 4 February this year having moved there from Scunthorpe and quickly became aware of the issue of a potential police office in Flamborough.

I was told that a site had been identified for use by local officers when in the area to use a telephone and a desk to save returning to Bridlington to make calls or complete reports. There was also a suggestion that if the demand existed, officers could, by prior arrangement hold occasional 'surgeries' for local people with policing complaints/queries. I was supportive of the principle and aware of several similar 'offices' in use or planned in the East Riding.

Clearly most of the planning for the Flamborough office occurred before I arrived and it soon became clear to me that the facility on offer had a cost implication in that the owner, quite understandably wished to charge a rent. I would add that the rent suggested was reasonable and not excessive.

Purely on that basis I had to call a halt to the project. The budget that I have is finite and I must exercise care in spending it, as it is public money. The force is committed to increasing the numbers of police officers on the streets and is recruiting new officers at unprecedented levels and now has more officers than ever before. In addition we have a strategy in place to develop the police buildings estate that will ensure we have our buildings where they are needed in the future.

As the Divisional Commander for the East Riding I have a responsibility to ensure my actions support those two priorities for the force. This will ensure more officers serve in the East Riding generally and of course at Bridlington and Flamborough. As you may imagine many small towns and villages would like a 'concrete' police presence in the form of an office, just like Flamborough and indeed wherever it is appropriate we try to develop one. However, such facilities must come free of charge otherwise our buildings' costs would spiral thereby damaging our efforts described above.

The opportunities to develop 'rent free' accommodation do actually exist, this being the case in several East Riding villages. I would thus urge the Flamborough community to try and find an alternative site so we can proceed.

I do appreciate the frustration and disappointment my decision has created in Flamborough and I can only apologise that expectations were unrealistically raised. I sincerely hope that new premises can be found quickly and we can "rebuild some bridges" with the people of Flamborough.

There is clearly a feeling that the people of Flamborough are dissatisfied with the level of policing and of course I am concerned about that. I have asked Inspector Love the Local Policing Team Commander to contact you and others in the community to discuss his arrangements for policing Flamborough and attempt to find solutions with local people for their problems.

I will attend (with Inspector Love if possible) your Council meeting at 7.30pm on Monday 8<sup>th</sup> April at the Village Hall and hopefully explain to a wider audience the policing of the area.

Finally, I apologise for the way in which these events have unfolded, and hope that the confidence of the community in the police can be restored as quickly as possible.

Police Report for Flamborough Parish Council meeting – 8<sup>th</sup> April 2002 Inspector Steve Love, Local Policing Team Commander, Bridlington North.

Introduce self, C/Supt Dowse and PC Cross.

I will update on various issues and provide an overview of levels of incidents within Flamborough and its surrounding area since January this year. Once done I will be happy to take questions about any general aspect of local policing. It is not realistic to expect me to speak on specific incidents — I cannot know enough about every one to do that and there are issues of confidentiality as well

Firstly the matter of the proposed Police Office in the village – this is still an ambition of mine to re introduce a Police base within the village of Flamborough. The recent events started late last year with PC Cross and I agreeing that such a base would be a good thing, PC Cross identified an office premise and preliminary negotiations were started between the owner and I. At that point I was hoping to get all matters finalised by 1 February of this year.

Because the estate strategy of Humberside Police is administered from outside the Local Policing Teams it was necessary to involve our Buildings Unit and officers far more senior than I. Throughout the initial negotiations it was made plain by me that there was no guarantee of success and everything would be done at a stage at a time.

In the New Year it was evident that a member of this parish council had taken it upon himself or herself to tell the Bridlington Free Press of the office and that it was definite and would open in February. I set the record straight with the Brid Free Press and wrote to the owner of the property reiterating the fact that there was no commitment on either side at that time.

On the day of the last parish council meeting I received notice of the decision that Humberside Police would not pay a rental for a local office such as was proposed in Flamborough. I was, and remain, disappointed by that decision, but I fully understand the reasoning behind it.

The situation now is that PC Cross and I, in conjunction with others, are looking at alternative ideas to provide a no cost method of introducing a base of some sort within this village, a base that would provide rest and toilet facilities along with the ability to complete paperwork and speak in private to members of the public. If any one has ideas or offers of premises please speak to Dave Cross or myself after the meeting.

It is a Bridlington Number that is used but directed to

a central switchboard at busy times and police

attendance can be diverted to a priority call. If anyone perceives themselves in danger or threatened they

must dial 999

Mr P Traves:

Why did the police refuse the councils offer of free

Police Office facilities for 6 months.

Answer:

Felt it was more important to have more police walking around the village, than using the office.

Mr V Crosthwaite:

The local policeman had been invited to the Youth Club meeting on three occasions when he was sat outside in his car but refused. Why?

Police:

Will investigate and advise reason.

*Cllr D Harvey:* 

Has not seen more police in the village.

P Answer:

Told police to knock on doors etc., to establish their

presence.

Chief Superintendent Dowse advised that an antibehavioural order could

not be made unless for serious crime. It would appear from what has been said that it is a small hard core of abildron looking in parental control causing the

children lacking in parental control causing the

disturbances and vandalism.

Cllor Crossland:

Why was the number changed from an 850 number

and loss of police local knowledge.

Police Report for Flamborough Parish Council meeting – 5<sup>th</sup> June 2002

Inspector Steve Love, Local Policing Team Commander, Bridlington North.

You will be aware that since our last meeting the increased level of targeted patrol by uniformed Police Officers has continued. There has been an average of 6 – 8 hours of extra patrol done over and above the presence of Dave Cross, per week. These hours of patrol have been during the evenings and on different days. This level is sustainable and you will recall that I said right from the start that any increase in Police patrol has to be proportionate and at a level that can be maintained.

There have been noticeable increases in calls for service generally and crimes in particular. Almost without exception the crimes are of a minor nature and directed against property rather than people – they are all taken seriously and investigated.

The extra patrolling by my officers has been noticed and commented upon by residents and has resulted in a number of local youths being spoken to – for example on 31 March PC Reed dealt effectively with a group who were drinking cider in the village, they were from the caravan site and that was where they were returned to. Similar contact has been repeated over the months and generally the officers reported few incidents but spoke to several people, usually in general terms rather that to warn regarding their conduct.

My perception is that the increase in patrol is effective and it is my intention is to continue. I also intend to periodically bring our mobile police station to the villages to provide a highly visible presence for a few days at a time. There will be no pattern to that as I consider that to be a more effective way of using that particular resource.

There will soon be a change in the personnel responsible for problem solving on the beat that includes Flamborough. Sergeant Tim Tomkins is moving to us from Bridlington South in a couple of weeks and it is my intention to put him at the head of this team, and hopefully I will introduce him at the next meeting.

One thing that struck me from our last meeting was that despite the complaints about youths causing annoyance no one put forward any suggestions regarding what the kids can do here. I have made contact with ERYC with a view to a youth worker assisting us in an evaluation of what resources can be made available to us from that quarter — I hope to have more to report on that soon.

In the meantime the figures for the last 3 months are as follows:-

about 1 crime every 2.5 days. The increase in reported crime is explained in part by the changes to reporting rules that were instigated on 1 April this year and has resulted in an increase in recorded crime of about 40% across the board – it also accounts for some incidents previously recorded as disorder being classified as "crime". I have no doubt that some of the increase is caused by people being more inclined to report incidents and for that I am grateful.

In conclusion I am confidant that we will continue to work closely together, along with other agencies to improve the quality of life of those who live in, work in or visit this village.

#### 4. MATTERS ARISING

- 1 Gas Light: Cllr Crossland has obtained the necessary unit, which is still awaiting fitting.
- 2 **Flamborough Village Map**: The OS map is not suitable for our purpose. Cllr Crossland suggested we contact Mr A. Halford, Headmaster at Headlands School to ascertain if the Art Department would be able to produce a relief map of the village, this was agreed.

#### 3. Allotments:

- a. It has been brought to the Council's attention that Mr L Robson's allotment is now one third covered with rubble supplied by Mr M Hesp. # Breach of the Allotment Tenancy Agreement by Mr Les Robson.

Ms Lancaster was advised of the breach of the tenancy agreement relating to allotments numbers 13 and 14 by Mr Les Robson who was using them to store rubble, bales of straw, trailers and other items. Ms Lancaster offered to obtain photographic evidence of this breach, and advised the Council of the various options available. Following full discussions it was decided that a letter be sent to Mr L Robson by Ms Lancaster advising him:-

- After serious deliberation by the Parish Council they decided an opportunity should be given to remedy the breach.
- 28 days Notice to clear allotments numbers 13 and 14 returning them to proper cultivation within this time.
- Failure to clear the two allotments would result in a formal Notice to Quit allotments 13 and 14.
- A formal warning over his aggressive behaviour towards Mrs Newlove.
- Full recompense of £230.00 being the cost of a replacement windscreen.
