In line with guidance issued by the government and the British Legion there would be an on-line Remembrance Day service this year. A wreath would be laid by the Parish Council. A two minute silence will be held on Sunday 8 November at 11.00 am; Clerk to investigate and publicise any further initiatives.

It was noted that a new Union flag had been purchased; however the lanyard had snapped in high winds and would be repaired before Remembrance Day.
