**105/24 APOLOGIES**

Apologies for absence were received from Councillor S Crossland and Ward Councillor T Robson.

**106/24 DECLARATION OF INTERESTS / DISPENSATIONS**

RESOLVED: a) that Cllr Couzens declared an interest in items 112 and 113 and would not participate in these items;

b) that no dispensations were requested.

**107/24 PUBLIC PARTICIPATION SESSION (15 minutes)**

A member of the public advised that speeding continued to be an issue on Lighthouse Road. An Officer from Humberside Police advised that a Patrol Officer would be attending.

**108/24 MINUTES**

RESOLVED: that the minutes of the Parish Council meeting held on Monday 2 December 2024 be approved and signed as an accurate record.

**109/24 COUNCIL ACTIONS**

RESOLVED: that all council actions had been completed.

**110/24 REPORT OF THE CLERK**

RESOLVED: that the Report of the Clerk be received.

**111/24 QUESTIONS / REPORTS FROM COUNCILLORS**

Councillors noted the following:

There were significant potholes in the road on Allison Lane and South Sea Road.

The dyke between Links Golf Club and Daneswood Farm was full and needed to be cleared.

The trees next to the church on Bempton Lane needed to be lifted as mud continued to fall down and the footpath was becoming narrower.

The Hartendale Gutter remained full and water would often flood onto Water Lane.

Mud on the B1229 road remained an issue. The Clerk had reported this however, had been informed that it was the responsibility of the land owners to clear the mud. Councillors noted that this had also been reported several times in the past and the issue remained of who had the authority to enforce cleaning of the road.

A streetlight at the junction of Constable Road and Stylefield Road was permanently lit.

A wreath would be required for the annual wreath laying ceremony at the Fishermen's Monument on Chapel Street.

Flamborough CE VC Primary School were looking to fill their governor vacancies. A skills gap had been identified around Special Educational Needs and/or Disabilities (SEND) therefore, it would be beneficial to appoint a governor with SEND experience.

RESOLVED: a) that the Clerk report potholes on Allison Lane and South Sea Road;

b) that the Clerk chase up the issues of flooding and mud on the roads;

c) that the Clerk report the streetlight at the junction of Constable Road and Stylefield Road;

d) that the Clerk purchase a wreath for the Fishermen's Monument;

e) that the governor vacancies at Flamborough CE VC Primary School be advertised.

#### **112/24 PLANNING APPLICATIONS**

Councillors considered the following planning application:

##### **24/03604/PLF**

Siting of 5 shepherd huts with hot tubs, construction of a sauna, secure bicycle storage, recycling and refuse storage, vehicular parking, footpaths, permeable track, construction of wildlife pond, associated landscaping and widening of existing access.

RESOLVED: that there were no objections to the planning application considered.

The Clerk presented two precept request scenarios, one where the precept request would remain the same and one where the precept would be increased by 3.9 percent. Councillors reviewed the budget and agreed that the 3.9 increase was in line with increases to expenditure.

RESOLVED: that the precept request with a 3.9 increase be approved for submission to the local authority.

The Clerk had included a report of hours worked by the previous clerk as part of the agenda. The additional work had been completed to assist the council with financial transactions during a delay with the change of mandate for the bank.
