**75/24 APOLOGIES**

Apologies for absence were received from Councillors P Couzens, S Crossland and F Holt.

**76/24 DECLARATION OF INTERESTS / DISPENSATIONS**

- RESOLVED: a) that no interests were declared;
- b) that no dispensations were requested.

**77/24 PUBLIC PARTICIPATION SESSION (15 minutes)**

Members of the public queried the outcome of the East Yorkshire Motor Services (EYMS) bus service consultation that had been held on 11 October 2024. Councillors noted that the meeting had been well attended however, it was agreed that further consultation may be required. The Clerk had received correspondence from residents in the village with further questions and would contact EYMS regarding the questions and to arrange further consultation.

It was raised that speeding on Lighthouse Road continued to be an issue. This had been reported to East Riding of Yorkshire Council (ERYC) previously. Officers from Humberside Police confirmed that they had no control over changing speeding restrictions as these were reviewed based on statistics such as the number of accidents within an area.

A member of the public raised that the footpath on High Street, next to the layby close to the Rose and Crown pub had started to crumble away. The Clerk would report this to ERYC.

The planning application for Balcary Barn was re-addressed. This was on the agenda and would be discussed later in the meeting.

- RESOLVED: a) that the Clerk contact EYMS regarding further consultation on the bus service;
- b) that the Clerk contact ERYC regarding the footpath on High Street.

Councillors noted the following:

- Flamborough CE VC Primary School were looking to increase wraparound care and would be holding open days.
- The grass around the War Memorial needed to be cut and nettles and thistles needed to be tidied prior to Remembrance Sunday.
- The no entry sign at Danes Dyke had continued to be ineffective and motorists were still driving up this route. This had been raised previously with ERYC however, the sign was advisory and not enforceable due to not being on the highway.
- The footpath on Lighthouse Road had continued to narrow and the bushes were overgrown, preventing wheelchair and pushchair access.

RESOLVED: a) that the Clerk arrange for the grass to be cut at the War Memorial;  
b) that the Clerk contact ERYC regarding the footpath on Lighthouse Road.
