The safety certificates requested in May had not been provided by the Sports Club Committee.

RESOLVED: that Councillor Major arrange for gas and electricity testing at the Pavilion at Parish Council's expense.

A new swing seat is required at the playground. Clerk to arrange.

39/22 To note and consider Correspondence:

The correspondence was noted.

The outline of planned events at the RNLI/Pre-School fundraising day was welcomed. Permission was given for a banner to be placed on the fencing around the Village Green advertising the event.

The correspondence/consultation regarding the proposed AONB was noted. AONB to be added to September agenda, and Clerk to write to Natural England advising them then any comments would be made after the meeting. Clerk also to make contact with CPRE for advice/assistance.

Clerk reported that a petition regarding the closed toilets at South Landing had been received too late to be added to agenda. She had contacted ERYC who were now arranging telephone call with YWT to ascertain what action they were taking. Petition to be sent to ERYC with request that ERYC themselves open toilets as a temporary solution.

(b) To approve bank reconciliation and budget monitor to 31 May 2022 (attached)

42/22 Allotments:

a) To receive verbal allotment report

Clerk reported that an allotment check had taken place on 13 June. The allotment whose tenant had been sent a warning letter was still overgrown and untidy and a further letter was sent on 13 June. Clerk checked plot on 4 July and work had been undertaken to tidy the plot.

b) To discuss and agree action re buildings on plots 26 and 27 (attached)

Following the Council meeting on 6 June and a request from a resident wishing to take on the above plots subsequent to the death of the existing tenant, Clerk had investigated the buildings further. It was recommended that the buildings be demolished due to the presence and likely deterioration of asbestos. It was noted that an electricity meter and pole were also present and that this, and the water supply, were both in the tenant's name. The electricity supply would need to be cancelled and the meter and pole removed before demolition could take place.

RESOLVED: that the electricity supply/meters and pole be removed, and water supply ceased if necessary, prior to the buildings on the plots, including bases, being demolished and removed. The plots to be returned to a cultivatable condition acceptable to the Parish Council and required certificates of safe disposal of waste to be supplied to the Parish Council. All costs associated with the above to be borne by the estate of the deceased tenant, as per tenancy agreement.

Clerk to liaise with the tenant's wife re above and to advise resident who wished to take over the buildings.

43/22 To note report from ERYC walkabout on 24 May (attached)

The report was noted; actions agreed to be checked later in the year.

It was noted that the grass cutting of verges etc. this year had been excellent; Clerk to write to ERYC

44/22 To discuss (following update) Flamborough Pre-School and relocation

Councillor Holt updated the Council regarding the relocation of and fundraising for the Pre-School. It was noted that the timescale for relocation was not as pressing as it had been but that the Pre-School were still keen to move to suitable accommodation as quickly as they could.

45/22 To receive update on:

a) Ginger Lacey Memorial Bench

Designs for bench to be passed to Clerk who will obtain quotes.

b) War Memorial renovations

Clerk to take advice on most suitable and hardwearing materials.
